The website thus stands at the intersection of all these activities and occupies a critical role in the organization's plans.

To achieve these objectives, the organization engages a competent technology partner to help keep technology and content up to date and ensure the best experience for the users. Additionally, AVPA engages the partner to add new features to the website in line with the organisation's evolving programs and goals.

The Assignment: AVPA Knowledge Sharing and Learning Hub/Centre

To enhance the capability of the AVPA's Knowledge Sharing & Learning Centre to deliver transformative learning experiences through cutting-edge programmes, strategic events, and actionable thought leadership.

Specifications

The Knowledge Sharing and Learning Hub should have the following features:

Site design:

- An attractive graphic layout that embodies the AVPA Knowledge Sharing and Learning Center brand and image and adheres to the AVPA branding specifications.
- Interactive and user-friendly.
- Be mobile-friendly.
- A design that allows regular improvements in look and features.
- Suggested a 6-page site, but open to recommendations that will work best.
- SSL/TLS secure connection and green bar enabled.

CMS – Content Management System

The selected consultant/firm will apply a highly user-friendly CMS that is easy to use and robust to support emerging website technologies - Preferably Drupal.

- The CMS should be dynamic and allow content to be easily updated by administrative staff without specialized web development skills.
- Ability to incorporate all our social media platforms (WhatsApp, Instagram, Twitter, LinkedIn, YouTube, etc.) **with live update options.**
- A Google Translate option in due course (testable beta version) of at least Kiswahili and French.
- Ability to work well with search engines.
- Incorporate Google Analytics.

CRM (should include, but not be limited to)

- Ability to host subscription options.
- Ability to set goals for fundraising, donors, tweets, petition signatures, signups, volunteers, followers, endorsements, event RSVPs, survey responses, suggestions, and more.

Deliverables

- The Hub e-platform website presents a visual look, and its functionalities are enhanced to provide a better experience to users, i.e., captures the latest trends for website presentations that are compatible and easily accessible to most common devices' browsers (Laptops, mobiles, and other handheld devices)

- Integration with a Content Management System (CMS) - preferably Drupal/WordPress-based on the best user-friendly tools, and integrate an effective search function
- Develop a user guide/manual for the website and the CMS, complete with the most common troubleshooting guidelines.
- Train AVPA staff on how to manage content on the new website.
- Upon approval, install the website on the hosting location, and transfer all archived content from the current website into the new website (images, text, embedded video, PDFs, HTML, photo albums)

The platform will be available in English for the 6-month pilot phase and translated to French, Kiswahili, and Spanish in subsequent phases.

Project Duration

The envisioned duration of this consultancy is for a duration of 30 days within 3 months between July and September 2025.

Project Management

To ensure the smooth implementation of the project, the vendor/consultant will perform the following tasks:

- Participate in an initial kick-off meeting to meet with the AVPA project team, to discuss the project, validate critical objectives, agree on learning objectives, and develop a project plan to guide the project through to completion.
- Continuous consultation and updates to the project team on the progress of the assignment
- Collaborate with the AVPA project team to manage content reviews.

Qualifications

- The consultant is expected to be a firm/company with extensive experience in website development and the development of similar interactive and analytic data hubs.
- Minimum of 5 years of experience in Web Development and Application Management
- Team members should possess a Bachelor's or Master's degree in Information Technology Management or any other relevant field
- Working experience within multicultural teams and international organisations or companies, and knowledge of Africa and development issues;
- Proficiency in Frameworks and CMS such as Drupal, Bootstrap, and AngularJS, among others
- Hands-on experience in JavaScript, JQuery, HTML, HTML5, CSS, CSS3, PHP, MySQL among others
- Web Programming and teamwork skills, excellent verbal communication
